Pursuant to Civil Local Rule 7-11, the Parties, through their respective undersigned counsel, stipulate and agree as follows:

1. On July 27, 2020, the parties appeared for a Case Management Conference. Kyndra Miller appeared for Plaintiff, and Patrick Moriarty appeared for Defendants.

2. At the parties' request, at the July 27, 2020 Case Management Conference, jury trial in this matter was set to begin on July 26, 2021.

3. On or about September 25, 2020, the parties filed a Stipulation to continue the trial date in this matter from July 26, 2021 to August 23, 2021, or the soonest date thereafter the Court is available, in order to accommodate lead counsel for Defendants' pre-planned family vacation.

4. On October 1, 2020, this Court approved the parties' September 25, 2020 Stipulation and rescheduled jury trial in this matter to commence on August 23, 2021.

5. On or about September 28, 2020, Kyndra Miller's home burned down in the Glass Fire in Sonoma County; Kyndra Miller is lead counsel for Plaintiff. In that fire, Ms. Miller's primary case files and notes for this matter were destroyed.

6. In order to permit Plaintiff's counsel sufficient time to recreate the necessary case files and to recover from personal hardship caused to her by the catastrophic Glass Fire, counsel for the parties have met and conferred, and have agreed to modify the pre-trial case schedule and date for commencement of trial in this matter as follows, subject to this Court's approval:
